## TO BE CREMATED

### Big Gathering at Funeral of Normanby Doctor

The people of Eston and district paid their last respects to-day to the late Dr. Francis Townsend, who died suddenly at his residence, "Killora," Normanby, on Tuesday. Dr. Townsend was on the medical staff of the Eston Hospital, and held a big practice in Eston and Normanby.

He was an exceedingly popular man, and the parish church was filled to capacity for a simple service prior to the remains being taken to Darlington to be cremated.
